Attribute	A "Seven"	An "Eight"	A "Nine"	A "Ten"
Strength of Composition	Composition is weak or has flaws. Image might be cluttered. Subject might be clear, but it is not very interesting.	Composition is good. It may have a flaw, but it does not detract significantly from the image. Subject is clear, but Interest level is just average.	Composition is very good. Composition and subject matter combine to create a strong impact. Interest level is high.	Composition is exceptional. Composition, subject matter, technical qualities and management of light combine to create a very strong impact.
Technical Qualities	Has one clear technical flaw or a few small ones.	May have a technical flaw, as long as it does not detract significantly from the image.	Generally, no technical flaws.	No technical flaws.
Management of Light	Picture is overexposed or underexposed. Harsh light not addressed adequately or contrast not handled as well as it could be.	The light was handled adequately.	The light was handled well.	The light was exceptional and handled extremely well.
Fits SPS Category	Fails to meet the standards of the SPS category (or Challenge topic).	Meets the standards of the SPS category.	Meets or exceeds the standards of the SPS category.	Meets or exceeds the standards of the SPS category.
Overall	C or Needs Improvement or Below Average. These images have at least one clear weakness that is hard to overlook.	B or Satisfactory or Average. These are good images with no glaring weaknesses, but do not have the impact of the better pictures.	A or Excellent or Above Average. These pictures have strong impact; good use of light and composition, and generally have no weaknesses.	A+ or Outstanding or one of the very best. These have great impact, exceptional use of light and/or perspective and no weaknesses.

### SPS Exhibition Categories

Digital Categories	Keys
Nature	Most restrictive category; must appear natural, no cloning, no "hand of man", no domestic animals or flowers, no zoo animals.
General	Moderate restrictions. Minor cloning to <u>remove</u> distracting elements is O.K. HDR is permitted to represent the actual conditions. No <u>adding</u> elements (i.e. a sky) from an unrelated picture or editing software.
Artistic	Least restrictions. Most anything goes, except all elements must be from your own photos or your own post processing. No downloading of any material. Images should show uniqueness, creativity and imagination, not just skill with editing. No image should be eliminated from exhibition simply because it looks realistic, provided it shows originality of concept.
Black & White	Similar to General regarding cloning and content editing. However, we accept conversion techniques that provide various creative looks. In the extreme, they should be entered in Artistic. Inclusion of a color that is not on the gray scale is no longer permitted.
Challenge	Similar to Artistic. Presentation of the assigned theme is very important.
